Within the Black community, mental health is deemed as a 'Swept Under the Rug' stigma that has been creating false illusions and assumptions for a long time. That stigma is the core component of the African Canadian response to mental illness, and therefore African Canadians who suffer from mental illness are less likely to seek treatment. As a result, very few studies have been done on the impact of mental illness in the Black community. This book removes the veil of shame that clouds the topic of mental illness in the Black community, challenges that misconception, gives a voice to Black Canadians living with mental illness and leaves the audience more informed and empowered.
